This Internal Complaint Committee (ICC) shall be conversant as per Vishaka Guideline stipulated by the Supreme Court of India, in Vishaka and others vs. State of Rajasthan case in 1997, regarding sexual harassment at workplace and directive issued by the Ministry of Human Resource Development, Govt. of India (University Grants Commission) Notification, New Delhi, dated 2 <sup>nd</sup>May 2016, and as amended from time to time (Available at the Principal's Secretariat & HR- Dept. for ready reference). To follow and execute, 'The Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressed) Act 2013" (hereinafter referred as "The Act"), Committee of this Institute will be functioning with following objectives:

To prevent discrimination and sexual harassment against women, by promoting gender amity among students and employees.

To lay down procedures for the prohibition, resolution, settlement and prosecution of sets of discrimination and sexual harassment against women, by the students and the employees.

To deal with cases of discrimination and sexual harassment against women, in a time bound manner, aiming at ensuring support

services to the victimized and termination of the harassment.

To recommend appropriate punitive action against the guilty party.

The Committee shall be conversant with the process of conducting enquiry, interim redressal, and other provisions as laid down in the Gazette of India, notification dated 2nd May 2016.

This circular supersedes the previous Circulars related to composition of Gender Harassment Committee/ POSH/ICC.
